

## **Customer Product Specification**

**Clarified Lime Juice Concentrate** is processed and clarified from quality limes to retain the characteristic flavor of the whole fruit. All shipments will meet the following specifications:

Brix 40° minimum uncorrected, product sold based on acid content

**pH** 1.8 - 2.9

**Titratable Acidity** 440 to 460 grams per liter as anhydrous citric acid

Clarity 90% minimum T at 625nm at 4.5°

Color 0.15 to 0.60 maximum absorbance at 430nm at 4.5°

**Flavor** Typical of a good lime flavor and free of off flavors

TPC2000 cfu/ml, maximumYeast1000 cfu/ml, maximumMold50 cfu/ml, maximum

Ingredients Clarified Lime Juice Concentrate

Packaging 52 gallon open top metal drums; or as specified

Storage Recommend 0° F maximum for storage and shipping

Shelf Life 1 year, if unopened and kept frozen

Additives Sulfur Dioxide is added at 2,500 ppm maximum to maintain quality of color
